The above topics are not exhaustive and papers which fall within the general theme of the conference will be considered for presentation. Conference proceedings will be published and made available at the conference. An abstract (**maximum of 250 words**) should be sent to the conference secretariat no later than **31 March 2010**. The Technical Review Board members would review the collected abstracts. Papers will be accepted on the basis that the named author will attend the Conference in person to make the presentation.

The conference official language is English. Putonghua speaking speakers are welcome provided that the presentation power-points are prepared in English.
